IB Tiers Program

1. Introduction

D Prime IB Tiers Program (hereinafter the “Program”) shall be subject to **the** terms and conditions contained herein (“Terms and Conditions”). The Program is a special tier program for all IBs that are registered under D Prime. The Program will include all the benefits that an IB of D Prime is entitled to.

2. How to Join the Program

1. To participate in the program the IB must be a registered and verified IB.
2. The IB must go to their client area and click the IB Tiers tab.
3. Review the terms and conditions
4. The redirection link to the IB tiers portal is provided in the client area.

3. Eligibility

1. The Program is available to all **new and existing IBs** and is subject to D Prime’s eligibility criteria as indicated in the [Client Agreement](#) and these Terms and Conditions.
2. The Program is available to IBs from all regions except China, Hong Kong, Macau, Taiwan, Korea, Japan and India.
3. To be eligible for the benefits of the Program, the IB must meet the following criteria for each level.

* The Capital Flight Ratio shall not exceed the assigned level of the Gross Deposits Ratio. In the event that the initially assessed level of the Capital Flight Ratio is greater than that of the Gross Deposits Ratio, the Capital Flight Ratio level shall be automatically adjusted downward to match the level of the Gross Deposits Ratio.

- For example, if the Gross Deposits Ratio is determined to be at Level 6 and the Capital Flight Ratio is assessed at Level 8, the Capital Flight Ratio will be capped and reassigned to Level 6 for the purposes of weighted average calculation and any related evaluation.

5. Terms and Conditions – Printed Materials

1. The quantity for all printed materials mentioned in the table below is the total amount allocated yearly.

2. The term N/A means that the IB is not entitled to the Printed Material in that specific tier.
3. The IB is allowed to place orders for printed materials only once per year.
4. The total quantity of all the items for the Printed Materials namely **Business Cards, D Prime Brochure and IB Brochure** must be ordered as a whole, and the quantity cannot be divided during the calendar year 2025.
5. If the IB does not meet the required quantity in one quarter, it can be carried over to the next quarter, but it would not be carried over to the next year. The quantity must be used up in the current calendar year 2025.
6. If any IB office material is not able to be shipped to a country for any reason the cash equivalent amount will be given to the IB. 50% of the cash will be given to the IB once the quotation has been received from the vendor. The remaining 50% will be given upon the completion of production of materials with proof of photos provided to D Prime via email at marketing@dooprime.com. Please note that the quotation from the vendor must state all the information clearly. The amount paid to the IB will be at the discretion of D Prime.
7. The cost of shipping any merchandise can either be borne by the IB or can be deducted from the cost of total merchandise. For example, if the cost of 100 brochures is USD 1,000 (the cost of 1 brochure is USD 10) and the shipping cost is USD100, the IB can choose to ship 90 brochures, and the shipping charges can be included or the IB can choose to ship 100 brochures and pay the shipping charges separately.
8. If the IB is in a country that has a D Prime office, the IB can either choose to collect the printed materials from the office or the IB can choose the option mentioned in point 6. under Terms and Conditions- Printed Material above with regards to shipping charges.
9. It is the responsibility of the IBs to find vendors to produce the merchandise. The IB would have to provide D Prime with a proof of invoice in this case. The reimbursement of the invoice will be done by the end of the second week after the invoice has been provided. The reimbursed amount will be

transferred to the wallet of the IB. The design of all the products will be the responsibility and under the discretion of D Prime.

10. If the IB is upgraded to a higher tier during the calendar year 2025, the IB will be eligible for the difference of the amount of the higher tier. Please refer to the example below.
 - a. If an IB is promoted from D Prime Advocate to D Prime Bronze Partner, then the IB will be eligible for an extra 15 units of Business cards. This applies to all the benefits under Printed Materials available for the IB in these Terms and Conditions.
11. If the IB is downgraded to a tier below, the IB will be eligible to the quantity that is available for that downgraded tier only. Please refer to the example below.
 - a. If an IB is downgraded from D Prime Bronze Partner to D Prime Advocate, then the IB will be eligible to only 50 units of Business Cards instead of 75.
12. If the IB has already exhausted all the units while being at the higher tier in the same calendar year 2025, then the IB will not be entitled to extra units in the lower tier.
 - a. For example, as a D Prime Bronze Partner the IB has already ordered 75 units of Business Cards before being downgraded to D Prime Growth Partner then the IB will not be entitled to another 50 units. This applies to all the benefits under Printed Materials available for the IB in these Terms and Conditions.
13. The request for any benefit in the IB tiers must be made within the timeline that has been mentioned on the IB tier website.
14. Once the request has been submitted via the IB Tiers portal the IB will be contacted within 5-7 working days via email at marketing@dooprime.com. The IB must respond with the corresponding delivery details namely Name, Email, Phone and delivery address for the delivery of all the requested items. The sole responsibility of providing the correct and accurate address lies with the IB. D Prime will not be responsible for any delivery issues that may arise due to the wrong delivery address given. All custom charges and other corresponding charges will be borne by

the IB. It is the responsibility of the IB to check their email and respond on a timely manner.

6. Terms and Conditions Marketing Merchandise

1. The term N/A means that the IB is not entitled to the Marketing Merchandise in that specific tier.
2. **Birthday Gift-** The Birthday gift can be redeemed once in the calendar year 2025. The Birthday gift would be a gift card of the brand that is available in the country of origin of the IB. If for some reason, the gift card is not available the amount that the IB is entitled to can be converted to cash. This decision lies solely with D Prime.
3. **Welcome Goody Bag with co-branded materials-** Each IB in every tier is eligible to one (1) welcome goody bag with co-branded materials. The goody bag will include the following namely premium bag (paper bag), pen and notebook, water bottle or multicable (depending on the availability of

the merchandise). The request for the goody bag can be made only once in the calendar year 2025.

4. **Pop-up Backdrop-** The IB must request for the said item via the IB Tiers website. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5-7 working days. The IB must respond to the email with the following information such as the content, images and language that is required to be mentioned on the pop-up backdrop. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. The IB will be informed on the number of days that will be required for the design via email. It is the responsibility of the IB to check and respond to the email on a timely manner.
5. **D Prime Paper Bag-** The quantity for D Prime Paper Bag that is shown in the IB tier website is the quantity that is available per quarter. The quantity of D Prime Paper Bag shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of D Prime Paper Bag 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
6. **D Prime Tote Bag-** The quantity for D Prime Tote Bag that is shown in the IB tier website is the quantity that is available per quarter. The quantity of D Prime Tote Bag that is shown in the table below is the quantity that the IB is entitled to for the current calendar year. The IB is entitled to request for the quantity of D Prime Tote Bag 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
7. **D Prime Wireless Charger-** The quantity for D Prime Wireless Charger that is shown in the IB tier website is the quantity that is available per quarter. The quantity for D Prime Wireless Charger that is shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of D Prime Wireless Charger 4 times a year

which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter.

However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.

8. **D Prime Umbrella**– The quantity for D Prime Umbrella that is shown in the IB tier website is the quantity that is available per quarter. The quantity for D Prime Umbrella that is shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of D Prime Umbrella 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
9. **D Prime Water Bottle**– The quantity for D Prime Water Bottle that is shown in the IB tier website is the quantity that is available per quarter. The quantity for D Prime Water Bottle that is shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of D Prime Water Bottle 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
10. **D Prime Notebook**– The quantity for D Prime Notebook that is shown in the IB tier website is the quantity that is available per quarter. The quantity for D Prime Notebook that is shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of D Prime Notebook 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
11. **D Prime Multicable**– The quantity for D Prime Multicable that is shown in the IB tier website is the quantity that is available per quarter. The quantity for D Prime Multicable that is shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for

the quantity of D Prime Multicable 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.

12. The IB is allowed to place orders for 25% of the allocated quantity per quarter. The orders for the marketing merchandise must be placed in the first and second week (subject to change) of every quarter. Any orders that do not meet the above-mentioned requirements will not be fulfilled.
13. The orders for the marketing merchandise that is available once per year must also be placed in the first and second (subject to change) of every quarter. Any orders that do not meet the above-mentioned requirements will not be fulfilled.
14. If the IB does not meet the required quantity in one quarter, it can be carried over to the next quarter, but it would not be carried over to the next year. All the allocated quantity must be used up in the current calendar year 2025.
15. If any IB office material is not able to be shipped to a country for any reason the cash equivalent amount will be given to the IB. 50% of the cash will be given to the IB once the quotation has been received from the vendor. The remaining 50% will be given upon the completion of production of materials with proof of photos provided to D Prime via email at marketing@dooprime.com. Please note that the quotation from the vendor must state all the information clearly. The amount paid to the IB will be at the discretion of D Prime.
16. The cost of shipping any merchandise can either be borne by the IB or can be deducted from the cost of total merchandise. For example, if the cost of 100 umbrellas is USD 1,000 (the cost of 1 umbrella is USD 10) and the shipping cost is USD100, the IB can choose to ship 90 umbrellas, and the shipping charges can be included or the IB can choose to ship 100 umbrellas and pay the shipping charges separately.
17. If the IB is in a country that has a D Prime office, the IB can either choose to collect the marketing merchandise from the office or the IB can choose the option mentioned in point 14. under the Terms and Conditions Marketing Merchandise section above with regards to shipping charges.

18. It is the responsibility of the IBs to find vendors to produce the merchandise. The IB would have to provide D Prime with a proof of invoice in this case. The reimbursement of the invoice will be done by the end of the second week after the invoice has been provided. The reimbursed amount will be transferred to the wallet of the IB. The design of all the products will be the responsibility and under the discretion of D Prime.
19. If the IB is upgraded to a higher tier during the calendar year 2025, the IB will be eligible for the difference of the amount of the higher tier. Please refer to the example below.
 - a. If an IB is promoted from D Prime Growth Partner to D Prime Bronze Partner, then the IB will be eligible for an extra 8 units of D Prime Paper Bag. This applies to all the benefits under Marketing Merchandise available for the IB in these Terms and Conditions.
20. If the IB is downgraded to a tier below, the IB will be eligible to the quantity that is available for that downgraded tier only. Please refer to the example below.
 - a. If an IB is downgraded from D Prime Bronze Partner to D Prime D Prime Growth Partner, then the IB will be eligible to only 20 units of D Prime Paper Bag instead of 28.
21. If the IB has already exhausted all the units while being at the higher tier in the same calendar year 2025, then the IB will not be entitled to extra units in the lower tier. Please refer to the example below.
 - a. As a D Prime Bronze Partner, the IB has already ordered 28 units of D Prime Paper Bag before being downgraded to D Prime Growth Partner then the IB will not be entitled to another 20 units of D Prime Paper Bag. This applies to all the benefits under Marketing Merchandise available for the IB in these Terms and Conditions.
22. The request for any benefit in the IB tiers must be made within the timeline that has been mentioned on the IB tier website.
23. Once the request has been submitted via the IB Tiers portal the IB will be contacted within 5–7 working days via email at marketing@dooprime.com. The IB must respond with the corresponding delivery address for the delivery of all the requested items. The sole responsibility of providing the correct and accurate address lies with the IB. D Prime will not be responsible for any delivery issues that may arise due to the wrong delivery address given. All

custom charges and other corresponding charges will be borne by the IB. It is the responsibility of the IB to check their email and respond on a timely manner.

7. Terms and Conditions- IB Office Materials

1. The term N/A means that the IB is not entitled to the Marketing Merchandise in that specific tier.
2. **Office Rent Sponsorship**-The rent sponsorship amount will be decided upon the discretion of D Prime. The decision will be based on certain factors including but not limited to size of the office, location, country of office, IB tier etc. The sponsorship amount can only be requested once a year during the calendar year 2025.
3. **D Prime Partner Certificate Design**- The IB must request for the said item via the IB Tiers website. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5-7 working days. The IB must respond to the email with the following information such as IB Name on the certificate and Proposed Logo/Design required on certificate. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. The IB will be informed on the number of days that will be required for the design via email. The said item will be delivered in a digital format to the IB via email. It is the responsibility of the IB to check and respond to the email on a timely manner.
4. **D Prime Partner Certificate (Design + Plaque printing)**- The IB must request for the said item via the IB Tiers website. The D Prime Partner Certificate (Design + Plaque can only be requested once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5-7 working days. The IB must respond to the email with the following information such as IB Name on the certificate and Proposed Logo/Design required on certificate. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. The shipping cost of the plaque has to be borne by the IB. The IB will be informed on the number of days that will be required for the design via

email. It is the responsibility of the IB to check and respond to the email on a timely manner.

5. **D Prime Partner Office Signage (Design)**– The IB must request for the said item via the IB Tiers website. The D Prime Signage benefit will be available only once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5–7 working days. The IB must respond to the email with the following information such as the name, content and language that is required to be mentioned on the signage. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. The IB will be informed on the number of days that will be required for the design via email. The said item will be delivered in a digital format to the IB via email. It is the responsibility of the IB to check and respond to the email on a timely manner.
6. **D Prime Partner Office Signage (Design + Production)**– The IB must request for the said item via the IB Tiers website. The D Prime Partner Office Signage (Design + Production) will be available only once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5–7 working days. The IB must respond to the email with the following information such as the name, language and content that is required to be mentioned on the signage. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. The IB will be informed on the number of days that will be required for the design via email. It is the responsibility of the IB to check and respond to the email on a timely manner.
7. **Roll up Banners (Design)**– The IB must request for the said item via the IB Tiers website. The Roll up Banner (Design) will be available only once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5–7 working days. The IB must respond to the email with the following information such as the content, language and images that are required for the Roll up Banner. The

provided information will be taken into consideration however the final decision of the design will be taken by D Prime. The IB will be informed on the number of days that will be required for the design via email. The said item will be delivered in a digital format to the IB via email. It is the responsibility of the IB to check and respond to the email on a timely manner.

8. **Roll up Banners (Design + Production)**– The IB must request for the said item via the IB tiers website. The Roll up Banner (Design + Production) will be available only once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5-7 working days. The IB must respond to the email with the following information such as the name that is required to be mentioned on the signage along with the proposed design, language and content that will be used for the signage. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. It is the responsibility of the IB to check and respond to the email on a timely manner.
9. **Table Flag**– The quantity for Regular Flag that is shown in the IB tier website, and the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of Table Flag once a year. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
10. **Regular Flag (Black or white)**– The quantity for Regular Flag that is shown in the IB tier website, and the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of Regular Flag once a year. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
11. **Branded Office Visual Elements**– The IB must request for the said item via the IB Tiers website. The Branded Office Visual Element will be available only once in the current calendar year 2025. Once the request has been

submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5–7 working days. The IB must respond to the email with the following information such as the size of the office, decoration required and IB logo materials required. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. It is the responsibility of the IB to check and respond to the email on a timely manner.

12. **Office Pen**– The quantity for the Office Pen that is shown in the IB tier website is the quantity that is available per quarter. The quantity for Office Pen that is shown in the table below is the quantity that the IB is entitled to for the current calendar year 2025. The IB is entitled to request for the quantity of Office Pens 4 times a year which is equivalent to once per quarter. If the quantity for the current quarter has not been used the quantity can be carried over to the next quarter. However, the quantity will not be carried over to the next year. The quantity must be used in the current calendar year 2025.
13. **Office Posters (Design + Production)** – The IB must request for the said item via the IB tiers website. The Office Posters (Design + Production) will be available only once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5–7 working days. The IB must respond to the email with the following information such as images, content and languages that are required. The provided information will be taken into consideration however the final decision of the design and production will be taken by D Prime. It is the responsibility of the IB to check and respond to the email on a timely manner.
14. **Wall Sticker for Office (Design + Production)**– The IB must request for the said item via the IB Tiers website. The Wall Sticker for Office (Design + Production) will be available only once in the current calendar year 2025. Once the request has been submitted the IB will be reached out to via our marketing email address at marketing@dooprime.com within the next 5–7 working days. The IB must respond to the email with the following information such as images, content and languages that are required.
